DELINQUENCY MANAGEMENT MODULE

OVERVIEW

The D-FAST® Delinquency Management (DM) Module is available as an optional module for D-FAST software users. This Module allows users to effectively track delinquencies and perform proactive follow up steps in an efficient manner. This follow up is essential so that bond covenants are maintained, delinquency rates are managed, and the Agency acts in a fiduciary manner.

Specifically, the DM Module allows one to oversee and manage the tracking and collection of delinquencies within your districts. The DM module's powerful Setup interface helps you to:

- Identify all delinquency management activities for each type of District
- Specify the rules, fee, and fee recovery method for each DM activity
- Create customized reports, letters, and exports for each DM activity
- Recover the fee for each activity from each delinquent parcel


DM activity types are created and managed via the Delinquency

Management Setup Wizard. Once your DM activity types have been defined, the Delinquency Management Wizard allows you to quickly and accurately select installments upon which to perform an action. One can also create a new DM batch from a prior batch and move those same installments forward in the DM process. For instance, it is possible to send an initial letter to all accounts with delinquent installments. After that, the initial letter batch can be the basis for a second letter, excluding those that paid as a response to the initial letter.


The DM Module also comes with a user-friendly printing interface that allows the user to select a range of districts and accounts for inclusion in a report, and then allows the generation of a report by account, by batch, or a summary. DM letters, notices and reports can be easily edited via the Report Designer that is included in D-FAST.

Using the DM Module will help control the entire delinquency management process, ensuring that delinquency rates are held in check and that all bondholder covenants are maintained.

Dear Property Owner:

Your property is located within the above-referenced District. According to the Los Angeles County Tax Collector, as of July 11, 2013, there are delinquent installments due on this property.

Note: These installments are part of your regular property taxes that become delinquent on December and April of every year. This letter pertains to current and/or prior year taxes.

This District was created by the City to fund public improvements in your area. When the District was created, bonds were sold to investors to raise money to pay for the improvements. A special tax is billed annually against your property to pay off the bonds. The City has covenanted to the owners of the bonds that it will take certain steps, including the eventual initiation of judicial foreclosure proceedings, on properties which have special tax delinquencies. The City may need to enforce this covenant even if you are delinquent for only one installment. Please note that this still applies even if you are participating in a Los Angeles County Tax Collector payment plan.

If the special tax delinquency remains on your property after 30 days from the date this letter is mailed, the City may be required to provide the delinquency information to an attorney for foreclosure against your property. At that time, the delinquency will be paid to the attorney, along with all applicable penalties, interest, attorney's fees and expenses. The legal fees will be at least \$500, in addition to your delinquency amount.

Please pay the delinquent special tax installments due on your property along with other taxes directly to the Los Angeles County Tax Collector. If you have recently paid, please contact your letter. If you have any general questions regarding this District or the special tax, please call 676-7516.
